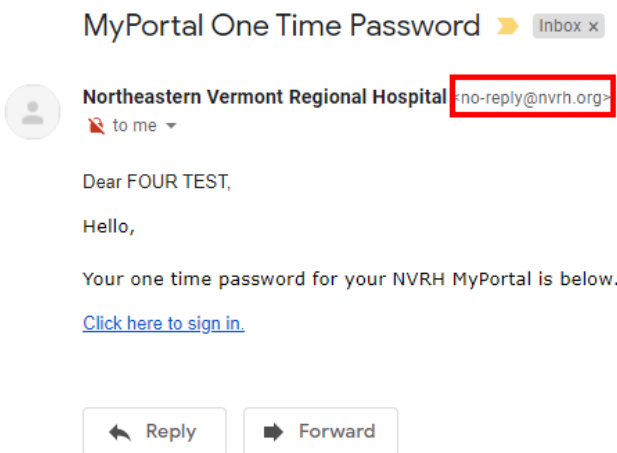




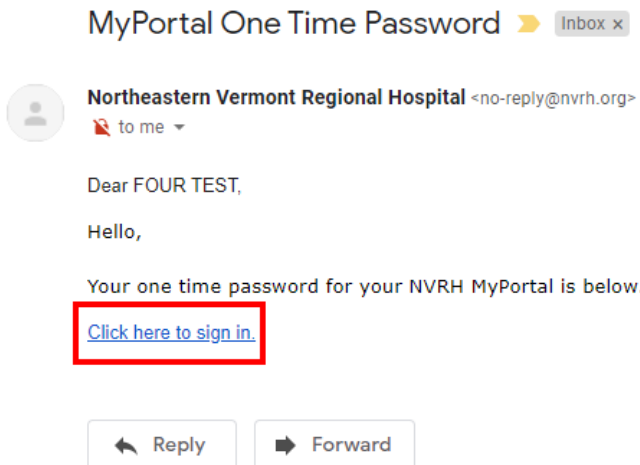
The following steps can be completed on a smartphone, tablet, or a computer. If you have a smartphone, please download the MEDITECH MHealth App (available on iOS and Android)



1. After a clinic staff member creates a portal account for you, you will receive an email titled **MyPortal One Time Password** from no-reply@nvrh.org that appears like the one below:



2. Select the “**Click here to sign in**” link.





- 3. This will bring you to the NVRH portal page to create your account. Start by creating a **Logon ID**. The requirements for the Logon ID are listed at the top of the page.
